### J. Council Reports Mayor Davis (written report)

So today begins our readings of the 2022 Budget Bylaw. There is no deficit this year, with a small surplus. Our water rates will increase this year to bring into line taxation with our actual costs. It is worth noting that our revenues break down thus: property taxes pay 40%; fees pay 31%; grants, 28%; investment income, 1.6%.

The Village of Tahsis multi-use community pier and dock project proposal has been approved by the federal government under the Investing in Canada Infrastructure Program. The grant totals \$2,475,547 and is 100% funded. We still have to go through environmental approvals, First Nations consent, provincial approval and final planning decisions as Council, with input from the public, before proceeding. Planning includes:

A main fixed pier which will include vehicle and pedestrian access;

Two floating docks will be attached on the south side;

The old seaplane ramp to be replaced with a boat ramp at the proper grade, with access float;

Improvements to access, parking, and boat trailer storage;

Hiab crane to be relocated to the new dock;

Float plane docking to be transferred to the new dock;

Support services including fire suppression, potable water, and electrical supply;

The old airplane dock is failing and will be removed to make way for it.

The new dock will be on the south side of the boat launch, next to Sally's Place.

Council to develop a wharf plan that can include a wharfinger. They will be responsible for collecting fees for docking, etc. which will go toward maintenance of the site. Council will have an opportunity to review and approve the design options and project budget once this work is completed next month.

Ownership of the old condemned wharf has been transferred to the Coast Guard, who will be responsible for demolishing it as well as environmental mitigation of the site. They will replace it with a closed dock for their use.

There is a 25% (\$460,000) contingency included in the approved grant funding. Moreover, the grant application included demolition costs for the former municipal wharf, which will no longer be required, as the Coast Guard is responsible for that work. Ministry staff have advised that the municipal wharf demolition costs can be reallocated toward other project costs.

Also of note is that we have received a \$10,000 planning grant for redevelopment of the old wood shop at the school as our new fire hall.

Another grant receiving conditional approval is \$4,385 toward opening the visitor centre this summer. We need double that and will have to make up the difference, pending council approval.

# Village of Tahsis 2022-2026 Financial Plan – Bylaw No. 649, 2022 Financial Plan Statement Schedule "B"

In accordance with Section 165 (3.1) of the *Community Charter* the Village of Tahsis is required to include in its 5-year Financial Plan (2022-2026):

- A) The objectives and policies of the municipality for the 5-year planning period in relation to each of the funding sources and the proportion of total revenue from each funding source; and
- B) The distribution of property value taxes among the property classes that may be subject to taxes; and
- C) The Use of permissive tax exemptions.

## A. <u>Proportion of Total Revenues by Source</u>

#### <u>Objective</u>

The Village will continue to review the proportion of revenue that is received from each source and seeks to balance the sources by seeking out new user fees, available grants and maximizing investment returns.

### **Policies**

The Village continues to review user-fees and charges to ensure that they adequately reflect the full cost of recovery within each utility. Where possible, the Village endeavours to supplement revenues from user fees and charges, rather than taxation, to lessen the burden on a limited tax base. Additionally, alternate revenue sources are continually examined to reduce the reliance on property taxes as the major source of funding.

## B. Distribution of Property Taxes Across Property Classes

### <u>Objective</u>

To ensure an equitable distribution of tax burden across all property classes.

### **Policies**

Over the term of the plan, municipal property taxes are distributed across six property tax classes as per Table 2 below. The Village regularly reviews the class distribution and makes adjustments when necessary with the goal to attracting and sustaining economic development.

## C. <u>Permissive Tax Exemptions</u>

<u>Objective</u>

Council may utilize its authority under the *Community Charter* to provide permissive exemptions to property owners who contribute to the community's social and environmental well-being, for example, greenhouse gas reduction, affordable housing, and Village revitalization.

### **Policies**

Permissive exemptions are granted to not-for-profit organizations that form a valuable part of and provide services to the community. In 2018 the Village, through Bylaw No. 609, granted a tax exemption, through to 2028, to the property located at 744 Nootka Road, the Bishop of Victoria, for 50% of the land value with estimated tax to be \$605 in 2021.

## BYLAW NO. 650, 2022

# A BYLAW FOR THE LEVYING OF RATES FOR GENERAL MUNICIPAL, REGIONAL LIBRARY, REGIONAL DISTRICT, WASTE MANAGEMENT, REGIONAL HOSPITAL DISTRICT PURPOSES FOR THE YEAR **2022**.

WHEREAS pursuant to section 197 of the Community Charter, Council must, by bylaw, impose property value taxes for the year by establishing the tax rates for the municipal revenue proposed to be raised from property value taxes and the amounts to be collected by means of rates established by the Village's taxing obligations in relation to another local government or other public body;

NOW THEREFORE the Council of the Village of Tahsis in open meeting assembled enacts as follows:

## 1. Definitions

1.1. Collector means the municipal officer assigned responsibility as Collector of taxes for the municipality and includes all persons appointed or designated by the Collector to act on their behalf.

2. Tax Rates for General Municipal Purposes

The rates and taxes named under this Bylaw are hereby imposed, levied, raised and collected for the year 2022 for the purposes stated and shall be payable in Canadian funds to the Collector at the Village of Tahsis, BC.

- 2.1 For all lawful General Municipal purposes of the Village of Tahsis on the assessed value of land and improvements taxable for General purposes, rates appearing in column 'A' of Schedule "A" attached hereto and forming a part of this Bylaw;
- 2.2 For Regional Library purposes of the Village of Tahsis on the assessed value of land and improvements taxable for General purposes, rates appearing in column 'B' of Schedule "A" attached hereto and forming a part of this Bylaw.
- 2.3 For Strathcona Regional District purposes of the Village of Tahsis on the assessed value of land and improvements taxable for Hospital purposes, rates appearing in column 'C' of Schedule "A" attached hereto and forming a part of this Bylaw;

- 2.4 For Comox Valley Regional District Services: Solid Waste Management purposes of the Village of Tahsis on the assessed value of land and improvements taxable for Hospital purposes, rates appearing in column 'D' of Schedule "A" attached hereto and forming a part of this Bylaw;
- 2.5 For Comox-Strathcona Regional Hospital District purposes of the Village of Tahsis on the assessed value of land and improvements taxable for Hospital purposes, rates appearing in column 'E' of Schedule "A" attached hereto and forming a part of this Bylaw;

## 3. Penalties

3.1 The Collector of the Village of Tahsis shall add to the unpaid taxes of the current year, for each parcel of land and its improvements of the property tax roll, 10% of the amount of the current year taxes which remain unpaid after July 4, 2022 and the said unpaid taxes together with the amount added as aforesaid shall be taxes of the current year due on such land and its improvements.

- 3.2 Tax rates and percentage additions caused as a result of a supplementary roll prepared under the Assessment Act shall be executed in accordance with section 241 of the *Community Charter*.
  - 3.3 The tax rates and taxes imposed under this Bylaw shall be payable at the offices of the said Collector at the Village of Tahsis Municipal Hall, 977 South Maquinna Drive, P.O. Box 219, Tahsis, BC, VOP 1X0, no later than 4:00 pm on July 4, 2022.
  - 3.4 Any and all amounts payable under this Bylaw shall be payable at the offices of the said Collector at the Village of Tahsis Municipal Hall, 977 South Maquinna Drive, P.O. Box 219, Tahsis, BC, VOP 1X0.

Thank you to those that were able to join me and my colleague Roly Russell, Parliamentary Secretary for Rural Development, on April 8 to discuss the \$830M provincial/federal funding partnership announced in March, and the plan to connect the remaining underserved rural and Indigenous households in our province to high-speed internet by 2027. With the new program expected to roll out this summer, I wanted to follow up on a few questions asked, and remind everyone how to connect to currently available information.

Connecting Communities BC is the next generation of our connectivity program and a key part of StrongerBC and the Economic Plan. This funding partnership is great news for the underserved rural and Indigenous households that will be able to look forward to the construction of connectivity infrastructure in their community, using multiple technologies such as fibre, cable, and satellite. These investments ensure that rural, remote, and Indigenous communities and businesses have the connectivity they need to succeed in a post-pandemic economy. It means all of B.C.'s communities will have better opportunities to contribute to the success of this province, and that's good for all of us.

We appreciated hearing your questions and feedback as we shape the new Connecting Communities BC program. It was affirming to know our regional approach reflects your previous input, which was our intent.
