J. Council Reports (written)

Mayor Davis

Back in August, I was invited to the Yuquot Spirit Summerfest, hosted by the Mowachaht/Muchalat First Nation. It was not my first, but I always enjoy spending time there, their traditional summer home. It was well attended and was the first to be held completely outside, due to the large numbers. It was the 100th anniversary of Yuquot being designated a National Historic Site. In attendance were our MLA, Michele Babchuk, Mayor Lott of Gold River, National Parks representatives, as well as writers and historians. I also found time to speak with Chief Maquinna, and Sanford Williams, their master carver, who now has a new building to do his work in. The feast was excellent and gifts were given to all attendees. I brought gifts for the four chiefs, including samples of our excellent Tahsis chocolate from Coal Creek Roasters.

On August 15, I met online with representatives from Fisheries and Oceans in order to speak regarding the federal net pen transition process. I spoke in favour of the transition to closed containment and advocated for investment in other sustainable seafood production methods, including seaweeds, as part of this process. I also spoke regarding reducing federal/provincial barriers to new permitting for alternate seafood production such as shellfish.

At my last Strathcona Regional District meeting, we voted in favour of the SRD establishing a housing service. This will allow us to apply for grants toward creating affordable housing in our region.

I recently learned of pending provincial transportation funding, following the recent provincial transit study. The timing is fortuitous as our regional district has previously been doing its own regional transit study and we will soon be voting on setting up a transit service for the SRD.

People will be aware that we are in phase 2 of our flood mitigation project construction. We have used the low water window to place riprap along two of the more erosion-prone stretches of the river. Effort was made to minimize tree removal, with some alder being removed in order to place riprap. The dike will be raised to prevent overflow in the case of an extreme flood event. The construction of the initial dike has prevented floods in the lower town, which has allowed people there to utilize their lower floors for more than just carports. In addition, effort will be made to re-establish the walking trail along the river side of the dike, with one stairway access being built over the dike.
