Dear Mayor and Council of the Village of Tahsis,

Thank You to the local resident who spoke up and alerted us about the misfeasance of Councillor and Deputy Mayor, Sarah Fowler. She was this year's coordinator for the Knights of Columbus Annual Christmas Food Hamper program for Tahsis. A local recipient was shocked and posted photos and this message to social media: "We have been receiving Knights of Columbus hampers for many many years. Longer than Sara Fowlr has lived here! WHY is there advertising for votes included with these hampers?"

In times of adversity and instability many individuals and families find themselves in need of assistance. Whether it be because of an illness, disability, unemployment, accident, fixed income, or the relentless surge in living costs; hard times can fall upon anyone. Recent reports underscore the growing number of Canadians resorting to food banks due to the prevailing financial strains.

The holiday season heightens the financial pressures and societal expectations. This is why the Knights of Columbus Annual Christmas Food Hamper is a program that residents are profoundly grateful to receive. Tahsis is not immune to these pressures and the food insecurities that often burden remote communities, again so many are thankful.

Unfortunately, the goodwill associated with this initiative has been compromised by the actions of this year's coordinator. Instead of preserving the pure intent of charity, she seized the opportunity to promote her small business food program, slipping in advertisements and even a flyer soliciting votes for her candidacy. Exploiting the platform by adding her municipal business card and a message falsely stating that the Village of Tahsis and/or the council is responsible for providing these hampers, not only steals the Knights of Columbus' limelight earned through decades of benevolence but also jeopardises their charity status.

Such conduct is not only unacceptable and disrespectful but also a betrayal of the charity's credibility and nobility; tarnishing their reputation. This is not merely a novice error but a violation of the public trust. A beginner's mistake followed by a genuine apology might be forgivable, but the lack of remorse and accountability exhibited by this elected official in her second term, is disturbing.

Given how frequently Councillor Fowler boasts about her accomplishments, training, and meetings she has attended, it is expected that she comprehends the privileged nature of holding an elected office and recognizes the associated responsibilities and obligations as a public servant. She has even gone so far as to publish her certificates in the council minutes and she routinely itemizes all her activities from the preceding week which she reads like a diary in her report to council. It is imperative to underscore that the role is not intended to subsidize personal interests at the taxpayers' expense, and it does not confer any form of arbitrary authority.

It is embarrassing to think that she represents our village at all the meetings she attends not only as a councillor but also as the Deputy Mayor. One of her numerous board seats is with the Union of BC Municipalities, they provide advice and training for local government officials plus they promote good governance, transparency, professionalism, and they created the Community Charter in which municipalities follow.

This lack of accountability (of mayor, councillors and other people in roles of authority) extends beyond the recent incident. Fowler has displayed a pattern of dishonesty, defamation of residents, manipulation of situations to her advantage, even undermining a fellow councillor and constituents who voice concerns for the community. Such behavior contradicts the principles of transparency and accountability that are foundational to effective governance. Her dismissive attitude towards rules and her belief in bending them for personal gain further erode trust in her leadership. This is the same person that said; "Easier to ask forgiveness than permission", "Rules are meant to be broken", "The majority rules", and "I govern a dying town".

The issue of questionable financial practices has come to light, including what appears to be triple-dipping the transportation expenses of the Good Food Box, a program administered by Greenways Land Trust. She refers to the program as the Tahsis Buyers' Club, her small business. The Village of Tahsis sponsors Councillor Fowler's yearly fuel expenses, despite her already charging a fuel surcharge to clients and Greenways covering transportation costs. The complex web of expenses becomes increasingly difficult to decipher, especially when other volunteers often bring the boxes to Tahsis for her.

This latest incident casts a shadow over the entire council, with the Mayor and Councillors seemingly condoning such unethical behavior by funding her and dismissing any questions and concerns raised by residents. The council seems to be uniting in a patronizing stance towards residents, asserting that they do not require input from constituents, that they don't deem it necessary to consult about projects and are solely responsible for making decisions on our behalf. This fosters an environment where such conduct is tolerated, widening the gap between council and residents further. The need for accountability and ethical conduct in public service cannot be overstated, and it is our collective responsibility to uphold the values that define us as a community.

What steps will Council take to correct this infraction? How will you restore public trust in the entire Council?

## PURPOSE OF REPORT:

To inform Council on the appointment of Kyle Wilkinson, as Fire Chief and Emergency Preparedness Coordinator effective January 15, 2024.

## BACKGROUND:

Kyle has a 20 plus year career in para-medicine and fire services in Ontario and Alberta. He has extensive training in all aspects of emergency preparedness and response including training through the U.S. Department of Homeland Security. His appointment, as per the Fire Protective Services and Regulation Bylaw, No. 621, 2019, is effective January 15, 2024. With the Fire Chief appointment comes the authorities under s. 66 of the *Community Charter* and the *Fire Services Act* to serve as a Local Assistant to the Fire Commissioner.

## PURPOSE OF REPORT:

To consider a regional grant application to the Community Emergency Preparedness Fund February 2024 Emergency Operation Centre (EOC) program from the Union of BC Municipalities (UBCM). This application would be in partnership with the Strathcona Regional District and other municipal and First Nation entities in order to provide funding for the Village's Fire Chief / Emergency Program Coordinator to work an extra one day per week on the Village's emergency planning and emergency operation centre training portfolio.

## **OPTIONS/ALTERNATIVES**

- 1. Provide a resolution as drafted
- 2. Decline to provide a resolution

Staff recommends **Option 1** in order to pursue an external funding opportunity

#### BACKGROUND:

The Community Emergency Preparedness Fund (CEPF) is a suite of funding programs intended to enhance the resiliency of local governments, First Nations and communities in responding to emergencies. The intent of this funding stream is to support eligible applicants to build local capacity through the purchase of equipment and supplies required to maintain or improve an EOC and to enhance EOC capacity through training and exercises. Eligible applicants can submit one application per intake, or as a partnering applicant in a regional application. It is proposed that the SRD will be the primary applicant in a regional application with the Village of Tahsis as a partner applicant. The deadline submission for this grant is February 28, 2024. In order to be considered as a partner, the Village of Tahsis is required to submit a Council Resolution that clearly states that they authorize the SRD to receive and manage the funds on behalf of the Village of Tahsis.

## POLICY/LEGISLATIVE REQUIREMENTS:

Section 2(3)(b) of BC Reg.380/95 (Local Authority Emergency Management Regulation) states that a local authority must prepare or cause to be prepared local emergency plans respecting preparation for, response to, and recovery from emergencies and disasters. The response to and recovery from emergencies and disasters is coordinated by the Emergency Operations Centre.

## **FINANCIAL IMPLICATIONS:**

The grant is 100% fully funded.
